PROFILE

Dariusz has fifteen years of experience working in international development and humanitarian settings, with a specialisation in research and monitoring, evaluation, and learning (MEL). He has successfully implemented a wide range of methodologies, from representative national studies to ethnographies and participatory action research, while working on an array of issues: youth violence, conflict, migration issues with internally displaced persons (IDPs), peacebuilding, violence against women and girls (VAWG), agriculture, governance, security system reform, education, child protection, public health, etc. His academic research focuses on gangs. Based on that research he published *Gang Entry and Exit in Cape Town: Getting Beyond The Streets in Africa's Deadliest City*, as well as articles in a number of peer-reviewed journals. Dariusz has also written as a journalist for *Al Jazeera*, *The Guardian*, *Globe and Mail*, and many other leading media outlets. He holds a doctorate from SOAS University of London, and is currently a Research Associate and Guest Lecturer at the Centre of Criminology, at the University of Cape Town's Faculty of Law.
